# Gun control study finds firearms expertise not utilised in Australia 29 January 2020

A University of Queensland study into the cost of gun control in Australia has found the stigmatisation of firearms dealers has caused them to be excluded from important discussions about firearms safety.

The Cost of Gun Control for Licensed Firearms Dealers in Australia study aimed to better understand how changes in firearms regulations can affect businesses - both financially and socially. Key findings include:

The level of bureaucracy makes it difficult for dealers to perform their mandated duties;

The expertise of dealers is not being utilised in contributing to better regulation of firearms;

Views of dealers are important given that the law-abiding firearms community play a critical role in maintaining gun registries and safe storage compliance; Law enforcement officers working in firearms compliance need more training so as to have a better understanding of the issues, dealers have;

Dealers have a vested interest in keeping firearms out of the hands of those who are not legitimate;

Dealers play a critical role in why Australia has had a successful experience with gun control;

The law-abiding firearms community has logical and sensible ideas to contribute to gun control policy. Senior lecturer in criminology at the University of Queensland and lead author of the study, Dr Suzanna Fay,

said much of the stigmatisation is influenced by negative media attention on the firearms community.

"Those negative stereotypes often paint gun owners and dealers as irresponsible and dangerous and not having society's best interests at heart. We did not find any confirmation of that," said Dr Fay. "Stigmatising groups this way in society is almost never productive."

One dealer involved in the study noted his personal experience with this matter. "My biggest issue in this industry, as a firearms dealer, is there is a 'them and us' attitude," he said. We're all working for the same end as far as I'm concerned."

One shooting association representative said the study shows there are options to improve workable gun control in Australia.

"The findings of this report clearly indicate that a culture of division is denying Australia the best possible opportunities of practical and workable gun control," he said. "Our licensed firearms dealers care about the work they do and they care about keeping people safe." Dr Suzanna Fay, University of Queensland

Shooting Australia recently (Oct 2020) announced the 2024 Junior World Championships for Pistol, Rifle and Shotgun disciplines will be held at the Sydney International Shooting Centre (SISC) at Cecil Park.

We had a really good turnout for the 2020 AGM.

The meeting opened with the minutes from the 2019 AGM being read to the members then Moved and Seconded as being correct and carried unanimously by a

interesting and exciting changes to come, assuming approvals are received, I understand we can be optimistic. Centrefire approval has been sought following extensive on-site testing, all of which was carried out legally following approvals from FAR and Council to do so. Now the reams of paperwork put forward with our application carry our optimistic hopes of approval soon. Our hours of shooting may be modified, starting at 10am through to 5pm and 6pm in daylight saving time. If approved it will mean more members shooting BUT also the need for more members to assist in the running of the shoot days, which will mean additional trained ROs will be required.

The "pond" (dam/billabong/reservoir) at the rear of the mound was found to be a "bit off centre" so it had to be moved, it will be shut down and the functionality/ facility it was to provide is currently being restructured to the rear of the mound and more to the South West, Tony G drew up the required engineering drawings for this project, saving the club several thousand dollars. The Treasurers report was presented by the Secretary with the Treasurer unavailable as he was heavily involved in some house moving duties. We are in a financially sound position (could always be better) and we are doing OK with no increases in membership fees called for. Good news.

Amendments to the PFA constitution was proposed and the rationale for these changes were discussed with the meeting. Members and their rights to vote and hold committee positions being the main points of discussion, life and full adult members being allowed full voting and the holding of committee positions whereas junior and social (associate) members are specifically excluded from these abilities.

The proposal was made, seconded and voted on from the floor with a show of hands and passed unanimously. Bruce Crowe, who unfortunately had to leave the meeting early was thanked for his expertise and assistance in making the constitution reflective of our club as a whole and ensuring that it does everything expected of it.

It was reported that we experienced the loss of three members who sadly passed away during the course of 2019/20, as we know, it's a fact of life but still extremely sad to lose anyone especially someone you know. Our thoughts are with their family and close friends.

A couple of questions coming from the floor were answered and with no further business to discuss the meeting was called closed at 11.19am. A good meeting is a short meeting.

Everyone was invited to stay back and have a chat, some very tasty wraps and a tea/coffee with most staying on for a while. It's great to have a chat with other members, some who you maybe haven't met yet and of course some very familiar ones. Some new faces were to be seen, which is encouraging seeing new members taking part in the club and its operation. **Derek BT. ED.** 

### **Attention to all PFA Members**

There is a Speed Limit of 10kph on the joint PFA/SIPC clubs Access Road (Driveway). One Sunday in August 2020 an Incident occured, that could have been a lot worse, when two vehicles from SIPC were apparently "speeding" up the access road and almost caused a collision with a vehicle leaving the PFA Rifle Range.

To make it clear to everyone, the Speed Limit on the access road/driveway is 10 KPH, no more. It should also be highlighted and noted that cyclists and

#### A BOOST TO THE ECONOMY.

Shooting delivers \$2.4 billion shot to Australian 23rd September 2019 economy. Australia's recreational shooters and hunters are happier, healthier and fitter than non-shooters, deliver a \$2.4 billion shot to the economy each year and create tens of thousands of jobs. The Economic and social impacts of recreational hunting and shooting report commissioned by former Federal Sports Minister Bridget McKenzie, now Minister for Agriculture, and successfully lobbied for by one of the shooting association of Australia has highlighted the benefits of the recreation to our nation. The report found 'hunting and shooting provides opportunities for physical activity as well as pathways for greater wellbeing' through connection with the great Australian outdoors. It also found shooters had greater confidence, enjoyed social networks, undertook more physical activity and had better nutrition than the average Australian. The economic benefit is more than five times that delivered by the Melbourne Cup each year and helps fight the monetary cost to Australia of \$3.7 billion in poor health and inactivity. A shooting association representative said: "Our Association's members should be congratulated for being environmental volunteers, removing pest animals which threaten our native flora and fauna."
