

Peninsular Firearm Academy Inc

Operational Plan of Management – 2020

The shooting range facility and associated clubhouse at Lot 101, DP 1106750, Mona Vale Road, Terrey Hills, will be managed and operated as detailed in this Plan of Management

1. Use of the Facility

Shooting days will be held at the facility once a month, currently the last Sunday of the month.

Training courses, the Annual General Meeting, Committee Meetings and Sub-Committee Meetings will be held on a regular basis as required.

The hours of operation for shooting will be from 10.00 am to 5.00 pm AEST, and from 10.00 am to 6.00 pm AEDT.

Up to 280 shooters can attend each shooting day in AEST and up to 320 shooters can attend each shooting day in AEDT.

The number of shooters is limited to 20 shooters per detail and cannot be exceeded. Each detail is 30 minutes in length.

The Shooting Range will not be used for any night time shooting purposes (at present) and no floodlighting of the range target area is permitted.

2. Operation of the Facility

The facility is to be operated in accordance with the relevant provisions of the Firearms Act 1996 and the Firearms Regulation 2017.

3. Safety and Security of the Building

No firearms or ammunition will be stored on site. No cash will be stored on site.

Club members and visitors will bring their own firearms and ammunition to the site. Peninsular Firearm Academy Inc will also bring firearms and ammunition to the site as required. The transportation of firearms and ammunition will be carried out in accordance with the relevant Act and its Regulations.

The Standing Orders for the club will detail the specific safety measures which are to be implemented at the facility. The standing orders of the club will prevail in the event of any inconsistency between the standing orders and this plan of management.

4. Noise and other Incidents Management

A complaints and/or incident register will be kept by Peninsular Firearm Academy Inc. The register will record all complaints received in relation to the shooting range facility, all incidents that occur at the shooting range facility, which are not part of normal club activities, and the action taken to address the issue. The register is to be available to Council Officers at their request. A copy of the OPM will be kept on site at all times, in conjunction with the complaints/incident register.

5.0 Traffic Management

The entrance gate to the shared driveway will be opened by range staff at the start of a shooting day and they will close the gate after the shooting day finishes. No other specific traffic management measures are required.

6.0 Access Maintenance Routine

All waste water is handled by the on site worm farm.

In the event that rainfall has been insufficient to keep the water tanks full, water will be delivered.

7.0 Garbage Collection

Normal commercial waste collection arrangements will apply.

8.0 Review of Plan of Management

The Plan of Management is to be reviewed on an as needs basis, or whenever altered conditions of use are being sought.
